QUESTION TWO [20 MARKS]

ii. Is the information with Linet a trade secret yet the product has not been launched? Give reasons for your answer. [3 marks]
iii. What are the properties that make information to be a trade secret and how should it be handled? [3 marks]
- b. As an IT professional with integrity, you have been employed as a database administrator. Detail with examples scenarios where your integrity can be compromised and write how you will act. [5 marks]
- c. Morality is influenced by different factors. Briefly discuss five that affect an individuals' morality [5 marks]
