A distinguishing characteristic of a profession is that practitioners combine ethical standards with the performance of technical skills. Supply management professionals must subscribe to a set of ethical principles and standards to guide individual and group decisions and actions. integrity, value and loyalty. From these our standards are established to encourage adherence to uncompromising ethical behavior, increase awareness and acceptance of ethical conduct, and emphasize the role of ethics when formulating decisions. These standards are guidelines for use by all who manage or influence the supply chain. The standards do not supplant an organization's policies but are a model for consideration. Every supply management professional is responsible to strive for acceptance and adherence to these ethical standards. Organizations are encouraged to develop, publish and enforce an ethics policy that supports these principles and standards. Policies and procedures must be clear, transparent and enforceable. The ethics policy should be shared with all employees, including those outside the supply organization, and with suppliers. Training must be on-going and comprehensive. Standards and guidelines cannot cover every situation, or nuance, and do not take the place of good judgment or sensitivity to other cultures, laws, customs and practices. When in doubt, consult with management and professional colleagues.
